Welcome to Saint Viator Hockey



- Saint Viator fields a Varsity and JV team.
- Both teams are fully recognized by the school and players are awarded the same varsity letters and minor letters as all other IHSA sports and follow the same school rules.
- The Varsity and JV compete in what is considered the strongest league in Illinois, Metro North. The Varsity also is a member of the Chicago Catholic Hockey League, which is one of the oldest leagues in the state.
- There are over 90 high school hockey teams in the state.
- The game totals for the JV approach 50 games and for the Varsity mid 60's. Practices are 2 to 3 times per week.
- Special skill clinics are offered and taught by NHL skill coaches up to 10 per year.
- The Daily Herald, Chicago Sun-times, Arlington Journal, Hockey Stop, Illinois Hockey, and Southtown Economist cover our games. This past year there were 3-featured articles in Daily Herald and 1 in Hockey Stop besides the standard game coverage. School coverage is provided by daily announcements.
- In the 2010-2011 season, the Varsity and JV teams had very successful seasons. The JV was the regular season Champion of Metro North and the Varsity went 42-18-6-1. Varsity ranked 4th in the state, and went to the semi-finals of the Catholic League playoffs. JV ranked 8th in the state.
- In the 2010-2011 season, Saint Viator had 2 All State players, 6 players chosen to tryout for the Team Illinois High School Showcase team with 3 of those players selected to represent Illinois. 1 player was chosen as a Blackhawk All State player, an honor awarded to only 6 players in the state.
- Players come from all types of hockey backgrounds and we take great pride in developing them into productive hockey players. The Varsity team had 8 players with AAA experience.
- Junior scouts and college coaches **DO** attend our games. This past year 3 Junior Clubs have directly contacted 5 players.
- The state High School Hockey Championship is played at the United Center televised on Comcast and attended by over 10,000 people.

The experience of playing high school hockey is a very deep and enriching experience. We are proud of our program and we welcome you to it.

✘ Saint Viator Registration Form and Tryout Fee:

- Due before player steps on ice for tryouts. **NO EXCEPTIONS.**

✘ USA Hockey Insurance:

- **All** Members / Coaches must have **CURRENT** USA Hockey Insurance in order to participate in tryouts. You can purchase your USA Hockey insurance at: (<http://www.usahockeyregistration.com/>) You have the option to email/fax your confirmation page with barcode or bring it to the first night of skate.

✘ Metro Participation / Medical Form:

- Completed with doctor's approval to participate.
- A standard physical form from your doctor is not acceptable for high school hockey. You must have your physician complete the CMHHL Participation Form to meet requirement.
- Due by mandatory parent / player meeting **NO EXCEPTIONS.**

✘ Tryout Fee per player \$300.00

- \$300.00 tryout fee is non-refundable.

✘ Outstanding Fee Balances:

- Any player that has any outstanding fees, including summer skate fees owed to the Club, will not be allowed on the ice until those fees have been paid. **NO EXCEPTIONS.**

~2010-2011 Fees and Payment Schedule~

✳ Varsity Player Fees:

- \$3,950.00 – includes all practice, games, and tournament entry fees (practice jersey, practice and game socks included)

✳ Junior Varsity Player Fees:

- \$3,500.00 – includes all practice, games, and tournament entry fees (practice jersey, practice and game socks included.)

✳ Goalie Fees:

- ½ of player fee dependent on team rostered to.

✳ Jerseys:

- All new players must purchase one Navy Blue and one White jersey through the club. Cost is approximately \$200 for the set.
- Any player who is rostered on the Varsity team will also have to purchase the Red alternate jersey for an additional fee.

✳ Payments:

- A three check payment system will be used for Fall Season hockey fees. Checks will be collected in advance, (Only EXCEPTION is if you pay IN FULL at beginning of season.)
- If a check is returned you will be charged a \$50/fee PER CHECK.
